It is important that we keep San Diegan’s in their home and provide some relief to individuals during this unprecedented time.

We understand that you do not have the authority to extend the filing deadline however, it is in your authority to waive fines, penalties and interest for late payments. Many other counties in California have already taken this action. Doing this will provide relief and flexibility for San Diego County residents.
